Rules & Regulations

The Anti-Ragging Committee will have following responsibilities:

- ✓ To ensure that no incidence of ragging as given in these regulations takes place at Noida Campus and will also monitor and ensure that the instructions of the regulations are followed fully at all times.
- ✓ To maintain alert vigil at all times and ensure that the Institutional Anti Ragging Committee and Anti-Ragging Squads of the Institutions carry out their functions properly.
- ✓ The Anti-Ragging Committee Nodal Officer to nominate Proctor in charge of Control Room.

- ✓ Coordinate with the Institutional Anti-Ragging Committees, and Anti-Ragging Control Rooms.
- ✓ Anti-Ragging Squads and Anti-Ragging Patrols will immediately report any incidence of ragging or abetment of ragging noticed by them to the Anti-Ragging Control Room to the Anti-Ragging Committee of respective Institution and the Nodal Officer of Anti Ragging Committee.
- ✓ Proctor in-charge of the Anti-Ragging Control Room will take immediate action as per the situation which may include:
 - i. Immediate suspension of involved students
 - ii. Sending reinforcements or any medical help if required.
 - iii. Forward the main gist / report of incident to the Anti-Ragging Committee Nodal Officer and Chairman.
